CONSENT, RELEASE, HOLD HARMLESS AND AUTHORIZATION TO REPRODUCE PHYSICAL LIKENESS

As used below, "Boy Scouts" shall mean Boy Scout Colorado Troop 59, as represented by its officers, agents, and assigns.

I am informed that the Boy Scouts will be photographing and/or filming material for use on our website and possible advertisements, and that the Boy Scouts have requested that I grant them the right to photograph me, and record my voice and likeness during events.

As the legal parent or guardian of _____, I (the undersigned) do hereby confirm the consent heretofore given the Boy Scouts with respect to the Boy Scouts photographing my Scout in connection with the Program, and I do hereby grant to the Boy Scouts, its successors and licensees, the right to use, reproduce, distribute to the public, perform publicly and display publicly, the films/tapes/recordings containing my Scout's voice and/or likeness and any and all revisions and reproductions thereof, in any and all media without limitation, throughout the world, and that the Boy Scouts shall have the right to authorize and license others to do so. I agree that the Boy Scouts may record all of said photographs on tape, film or otherwise and use said photographs and recordings, including the use of my Scout's voice and likeness therein contained, in connection with the Scouting Program, for advertising, promotion, exploitation, and any other use in connection with the Program as the Boy Scouts may desire throughout the world and in perpetuity in any and all media now known or hereafter devised. The Boy Scouts may use my Scout's name, voice and likeness and other information concerning me at the Boy Scout Program's sole discretion.

I expressly acknowledge that the Boy Scouts have no obligation to use my Scout's voice, likeness or name and further acknowledge that the Boy Scouts may delete, edit, change, and/or rearrange all or any of the foregoing. I acknowledge that any opinion expressed by my Scout during filming is my Scout's own, and not the opinion of the Boy Scouts. I further agree that the statements made by my Scout during filming are true and correct to the best of my knowledge.

I hereby unconditionally release the Boy Scouts from and against any and all claims, liabilities, demands, actions, causes of action, costs and expenses, whatsoever, at law or in equity, known or unknown, anticipated or unanticipated, suspected or unsuspected, which I ever had, now have, or may, shall, or hereafter have by any reason, matter, cause or thing whatsoever, arising out of my Scout's performances, your photographing my Scout, or the broadcast or use of such photographs or recordings.
